


WELCOMING CUSTOMERS BACK

SOCIAL DISTANCING

Social distancing is expected to remain in force for some time.

Current government guidance says:

"People should either stay 2m apart or '1m plus' – which is one metre plus mitigations. These mitigations

will depend on the workplace or setting. For example, on public transport, people must wear a face covering, as it is not always possible to stay 2m apart.

"In other spaces, mitigations could include installing screens, making sure people face away from each other, putting up handwashing facilities, minimising the amount of time you spend with people outside your household or bubble, and being outdoors."

Restaurants have until **31 August** to register for a new Eat Out to Help Out scheme – check <u>www.folkestone.works</u> for more information.

FACE COVERINGS COMPULSORY FROM 24 JULY

It's compulsory to wear a face covering in shops and supermarkets from **24 July.** The new rule does not currently apply to retail staff.

Current government guidance states:

"...shops and supermarkets will be expected to encourage compliance with the law (as they would do more generally) and can refuse entry. In both cases, if necessary, the police have the powers to enforce these measures, including through issuing a fine of £100 (halving to £50 if paid within 14 days)."
