COMMUNITY SUPPORT OFFICERS

Two new community support officers funded by central Government will help residents and businesses stay safe by complying with COVID-19 regulations in the Folkestone & Hythe district.

They will give clear information on how reduce the risk of spreading the infectious disease. This includes promoting NHS Test and Trace, visiting businesses to ensure appropriate measures are in place and having conversations with the public where necessary.

The officers will complement the work already carried out by Folkestone & Hythe District Council's Community Safety Unit, environmental health teams and area officers – as well as Kent Police.

FREE CAR PARKING IN DECEMBER

Folkestone & Hythe District Council has waived charges in council car parks and on-street pay and display parking bays for the three Saturdays before Christmas (5, 12 and 19 December).

- **Hospitality -** e.g. pubs, bars, restaurants and cafes
- Tourism and leisure hotels, museums, cinemas and amusement arcades
- **Close contact services -** hairdressers, barbers
